#### 1. Travel

Travel distances	Amount

**Nota bene:**

the "travel distance" represents the distance between the place of origin and the venue, whereas the "amount" covers the contribution to the travel both to and from the venue.

**4. Linguistic support**

Only for learners mobility lasting at least 19 days (excluding travel days) and only for languages not covered by Online linguistic Support (OLS): 150 EUR per participant
