Accreditatie van joint programmes vereenvoudigd:

- ECA: wederzijdse erkenning door MULTRA
- NVAO: overeenkomst met Duitse Akkreditierungsrat
- Bologna: Europese aanpak voor kwaliteitszorg van *joint programmes*

= een geïntegreerd curriculum dat gezamenlijk gecoördineerd en aangeboden wordt door verschillende HO instellingen uit verschillende Bologna landen, resulterend in meervoudige diploma's of 1 gezamenlijk diploma

Standaard 1.3 Samenwerkingsovereenkomst

The terms and conditions of the joint programme should be laid down in a cooperation agreement. The agreement should in particular cover the following issues:

- Denomination of the degree(s) awarded in the programme
- Coordination and responsibilities of the partners involved regarding management and financial organisation (including funding, sharing of costs and income etc.)
- Admission and selection procedures for students
- Mobility of students and teachers
- Examination regulations, student assessment methods, recognition of credits and degree awarding procedures in the consortium

Accreditatieprocedure volgens Europese aanpak

1. Zelfevaluatie-rapport: inbreng consortiumpartners
2. Panel: min. 4 leden, incl. 1 student, afkomstig uit min. 2 consortiumlanden
3. Locatiebezoek: vertegenwoordiging alle locaties
4. Panelrapport: bevindingen, analyse, conclusies, aanbevelingen
5. Besluit
6. Bezwaar/beroep
7. Rapportage: publiceren, tenminste Engelse samenvatting
8. Follow-Up
9. Accreditatietermijn: 6 jaar, informeren over wijzigingen
